



## Minutes for June 10, 2025 Council Meeting & Public Hearing

The Howardwick City Council met for a *Public Hearing* followed by a regular session on Tuesday, June 10, 2025 at 6:00pm in City Hall with the Mayor, Mayor Pro-Tem, Council Members, City Secretary and 6 guests.

**PUBLIC HEARING:** Mayor Johnny Floyd called public hearing to order at 6:00pm.

1. Council to discuss Hazard Mitigation Plan for Donley County.: Council went over plan and discussed major topics. Guests were asked if they had any questions or comments. No comments were given.
2. Approve resolution #190, adopting 2025 Mitigation plan: After discussion, Johnny Hubbard made a motion to approve Resolution 190, adopting the 2025 Mitigation Plan. Terry Barnes seconded the motion. Vote taken. All approved with none opposed. Motion carried.
3. Adjourn Public Hearing: Mayor adjourned public hearing at 6:13pm

1. Call to order: Mayor called regular meeting to order at 6:13pm
2. Invocation: Johnny Floyd gave the invocation
3. Pledge of allegiance: Everyone stood for the Pledge of Allegiance
4. Approve bills due: Mayor asked about check for Attorney, then Terry made a motion to pay the bills. Jada seconded the motion. Vote taken. All approved with none opposed. Motion carried.
5. Approve minutes for May 13, 2025: Johnny Hubbard made a motion to approve the minutes from 5-13-25. Matt seconded the motion. Vote taken. All approved with none opposed. Motion carried.
6. Mayors comments: Johnny Floyd reminding everyone about the upcoming HoeDown and that we needed donations for the pulled pork. Terry, Jada, Eddie and Sandy all agreed to donate 3 a piece. Mary and Jada said they would make the potato salad!

7. Citizens comments and/or Public comments on Agenda items: At this time any citizen who has filled out an appearance card prior to meeting will be heard in order that card was turned in and as time allows. Each person will have 3 minutes. In accordance with the Texas Open Meetings Act, the City Council may not deliberate or vote on any matter raised regarding Citizens comments. 
